PROGRESS REPORT ON REGISTER OF LABORATORIES RETAINING VARIOLA VIRUS

As of 28 July 1977, 17 laboratories in 10 countries are registered as retaining variola virus. Table 1 shows the number of countries per region, the number approached and the number from which information has been received. The table also shows the total number of laboratories included in the survey and the number identified as retaining variola virus.

During the period 9 February 1977 - 28 July 1977, 8 laboratories previously registered destroyed or transferred their variola stocks, bringing the total number of laboratories having destroyed their variola material to 57. Information was received from 8 more countries, leaving 5 countries in two regions which still have to reply to the original enquiry:

All these countries are under close follow-up.

Table 2 lists the laboratories with variola virus. Out of the 17 laboratories 6 are WHO Collaborating Centres.

The following comments can be made:

1. We are in contact with the laboratory in South Africa but due to the situation of this country within WHO, not much pressure can be employed to persuade them to destroy the virus.
2. During the World Health Assembly, contact was made with the delegates from Peru and Brazil and further action is awaited in the near future.
3. The situation in the USA is more or less stationary, since both the American Type Culture Collection and the Walter Reed Army Institute have raised rather strong objections to destroying their variola material.
4. During the discussions on the smallpox programme at the World Health Assembly, the U.K. representative stated that they will reduce the number of laboratories there to only 1 within 6-9 months' time.
5. It is expected that with the strong recommendations at the last World Health Assembly and the decision of the U.K., the West German laboratories will soon decide favourably on our request to destroy the virus.

Needless to say, the present situation is under close follow-up and we have good hopes that the number of laboratories will be further reduced in the near future.
