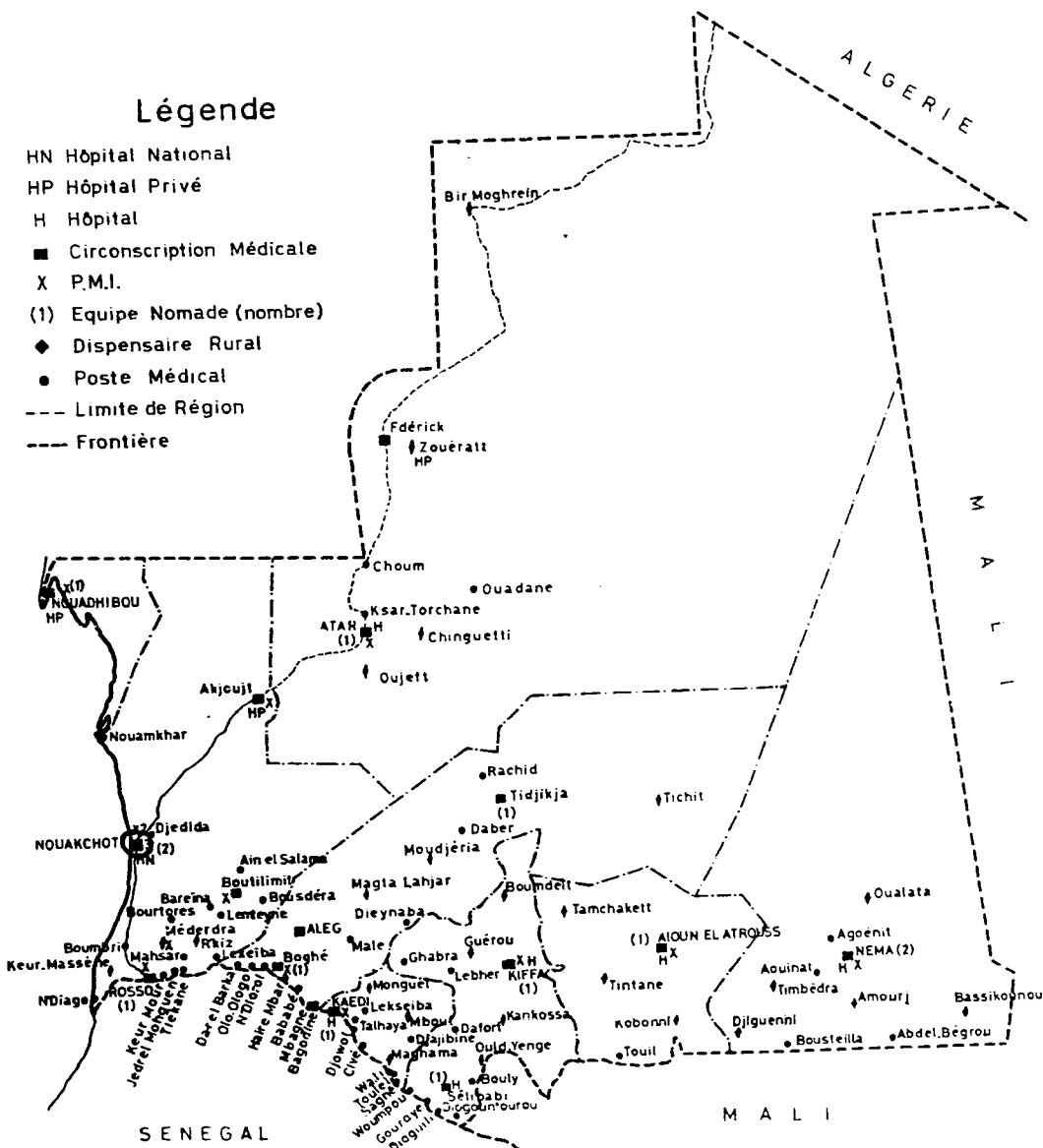
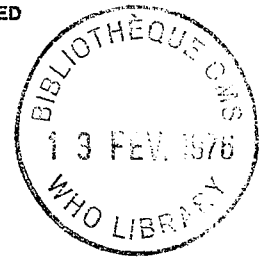

PART 1. PROGRAMME PERFORMANCE

1.1 The Smallpox Eradication Campaign in MAURITANIA began at the end of the third quarter of 1968.

Six mobile vaccination teams were established in six of the eight regions into which the country was divided (NEMA, AIOUN, KIFFA, KAEDI, BOGHE and ROSSO).

In June 1972 five additional teams were created and established at ATAR, NOUADHIBOU, SILIBABY, TIDJIKJA and NEMA.

1.2 The attack phase ended in December 1973, having covered the entire territory of Mauritania. The cumulative number of smallpox vaccinations was 1 387 332.

In 1969 an assessment team was established to evaluate the level of vaccination coverage. This was done by house-to-house visits, which revealed that less than 50% of the population had been vaccinated.

As this coverage was inadequate, it was necessary for the mobile teams to tour the entire country.

A second assessment was made in 1973-1974 using the same system, and this time the figures were satisfactory, 85% of the entire population having been vaccinated.

1.3 Surveillance - containment programme

1.3.1 The static health units send a monthly report to the Medical District, which draws up a consolidated report that is sent to the Ministry of Health in the capital by post. The mobile teams send their reports direct to smallpox eradication headquarters and a copy to the Ministry of Health.

Means of communication (both nil and suspect case reports):

- from reporting unit to district
- from district to state/province
- from state/province to national level

In the first case the reports are handed in personally by the services concerned. In the second and third cases the reports are sent by post.

Should a suspect or confirmed case be found, the report would be made by telephone or telegraph if available.

There are no nil reports.

1.3.2 No case of smallpox has been reported in the Islamic Republic of Mauritania since 1964.

1.3.3 There is no epidemiological information on an outbreak of smallpox since 1964.

PART 2. SURVEILLANCE AND VACCINATION PROGRAMME (1973-1975)

2.1 Surveillance programme

2.1.2 Reports normally take a month or so to arrive.

There are no nil reports. (See annex)

2.1.3 Only one suspect case has been reported in the city of Nouakchott. The case was investigated by the Epidemiological Officer of Health and diagnosed as chickenpox; notwithstanding the clinical diagnosis specimens were sent to headquarters.

2.2 Vaccination programme

2.2.1 Since 1973, the maintenance and epidemiological surveillance phase has been the responsibility of the mobile teams, of which there were twelve until March 1975, when their number was increased to sixteen. These teams are based on the regional capital, from which they make regular monthly tours to vaccinate young children.

A monthly report is regularly sent to WHO headquarters and a copy to the Ministry of Health at Nouakchott.

The static health units outside the capital are not at present able to assume responsibility for the maintenance phase of the smallpox eradication campaign since they do not possess the necessary means of conserving the vaccine.
